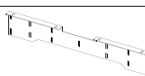

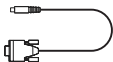

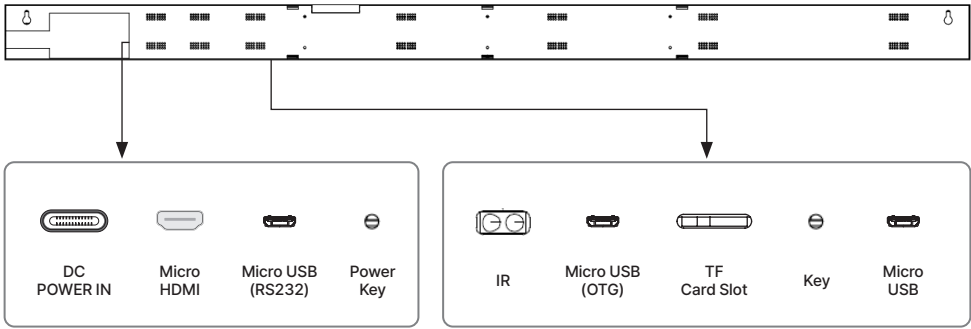

Port	Description
DC Power In	Connect the power cable to supply power.
Micro HDMI	Connects to a source device using a HDMI cable or HDMI-DVI cable.
RS232 (via Micro USB)	Provides RS232 serial communication using a Micro USB to RS232 interface cable. USB device functionality and USB data communication are not supported.
Power Key	It is used for entering Standby Mode.
IR	Receives infrared signals from a remote control for operating the signage.
Micro USB2.0(0.5A) (OTG)	Connect to a USB memory device. The USB ports on the product accept a maximum constant current of 0.5A. If the maximum value is exceeded, USB ports may not work.
TF Card Slot	This is the port for using TF cards
Key	It is used only for development purposes.
Micro USB2.0(0.5A)	Connect to a USB memory device. The USB ports on the product accept a maximum constant current of 0.5A. If the maximum value is exceeded, USB ports may not work.

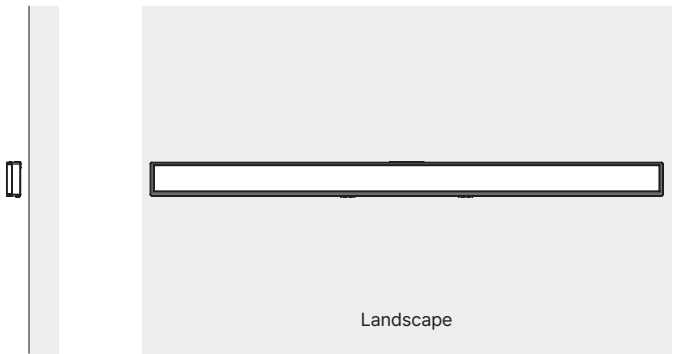

Before Installing the Product (Installation Guide)

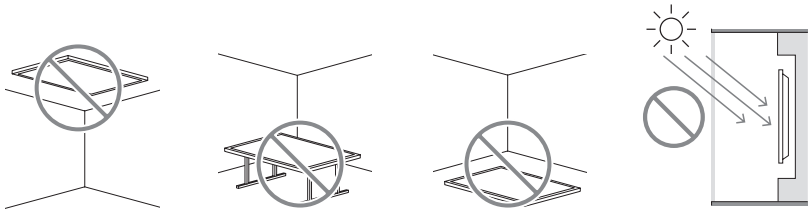
To prevent injury, this apparatus must be securely attached to the floor/wall in accordance with the installation instructions.

Keep the product away from direct sunlight. The product can be damaged.



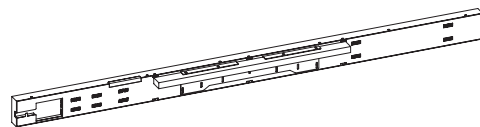

Installation on the shelf

- Ⓐ Ambient temperature : Under 35°C



Install in a well-ventilated area to prevent overheating.

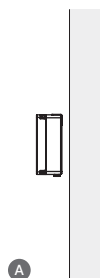
For ventilation, leave at least 50 mm of space between the product and other objects.

* Especially when installing near temperature-sensitive products (e.g., refrigerated or fresh food), ensure sufficient ventilation and be mindful of rising ambient temperatures, as the device's heat may affect adjacent products.

Installation on a Perpendicular Wall

- Ⓐ Ambient temperature : Under 35°C

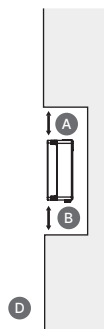
When installing the product on a perpendicular wall, allow at least 50mm of space between the product and wall surface for ventilation and ensure that the ambient temperature is kept below 35°C.



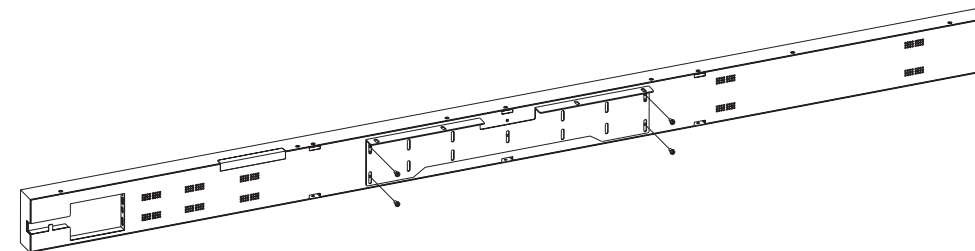
Installation on an Indented Wall

- Ⓐ Minimum 50 mm
- Ⓑ Minimum 50 mm
- Ⓒ Minimum 50 mm
- Ⓓ Ambient temperature : Under 35°C

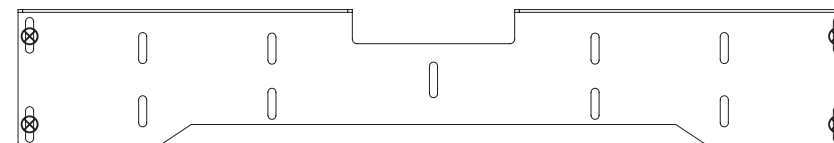
When installing the product on an indented wall, allow at least the space specified above between the product and wall for ventilation and ensure that the ambient temperature is kept below 35°C.



Method of Fix the Set on the Bracket



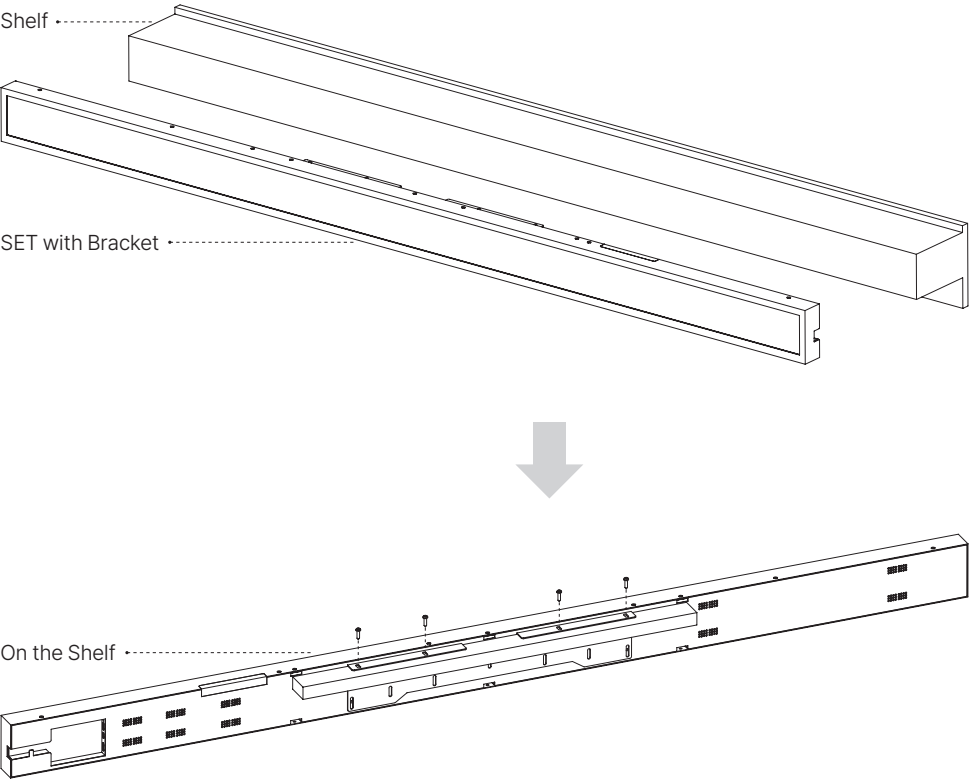
Point for fastening the screw



Screw Size : Diameter BM3, Length 5 mm

- 4 Point screws are supplied assembled to the set and bracket.
- Unscrew the assembled screws.
- Turn the bracket over, and fasten the screws.

Installing on the Shelf Using Bracket



Screw Size : Diameter PWA3, Length 10 mm

- You can hang the product on the shelf using the bracket.
- The images provided are for reference only.
- It is recommended to seek help from a technician when installing a wall bracket.
- SOLUM is not responsible for any damage to the product or injury to you or others caused by arbitrarily installing the wall mount.
- Install the product so that the plug is easily accessible.
